Sub: Outcome of Board Meeting under Regulation 51(2) read with Part B of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Please be informed that the Reserve Bank of India (RBI) vide its Circular No. DoS. CO.ARG/SEC.01/08.91.001/2021-22 dated April 27, 2021, has issued "Guidelines for Appointment of Statutory Central Auditors (SCAs) / Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and Non-Banking Financial Companies ("NBFCs") (including HFCs) ("RBI Guidelines"). The said RBI Guidelines are applicable w.e.f FY 2021-22 and onwards.

In view of the above, we hereby wish to inform you that the Board of Directors of the Company at its meeting held on December 07, 2021:

1. Took note of the letter dated December 07, 2021, received from Walker Chandiok & Co. LLP, Chartered Accountants (ICAI Firm Registration Number: 001076N/N500013) communicating that they would be resigning as the Statutory Auditors of the Company, w.e.f December 07, 2021, in view of their ineligibility to continue as the Statutory Auditors, upon completion of the stipulated tenure of 3 (three) years. A copy of the letter intimating their resignation is enclosed herewith and annexed as Annexure – I.



2. Based on the recommendation of the Audit Committee of the Company at its meeting held earlier today, i.e. December 07, 2021, approved the appointment of MSKA & Associates, Chartered Accountants (ICAI Firm Registration No. 105047W), as the Statutory Auditors of the Company for a continuous period of 3 (three) years, viz. FY 2021-22, FY 2022-23 and FY 2023-24, subject to the approval of the Shareholders of the Company at an ensuing Extra Ordinary General Meeting of the Company.
